Nollaig Forrest, Chief Marketing and Corporate Affairs Officer. Forrest currently serves as Holcim's Chief Sustainability Officer and oversees corporate affairs and branding.

Steve Clark, Chief People Officer. Clark was formerly Chief Human Resources Officer at Gainwell Technologies, Vista Outdoor and the H.J Heinz Company.

Denise Singleton, Chief Legal Officer & Corporate Secretary. Singleton was formerly General Counsel & Secretary of WestRock Company, IDEX Corporation and SunCoke Energy.
